Due to complex logistics on site a professional service partner has been selected. The Swiss company Bollhalder Industrielogistik AG will be responsible for the proper dismantling and loading of lots onto the transport of the buyer. The costs for this mandatory service are shown per lot as 'Additional costs' and will be added to your bid. Lot numbers above 200 are already properly dismantled by and stored at the company Bollhalder (at which viewing and pickup is only by appointment).

Collection date Information The buyer must bring their confirmation of payment or invoice for collection to the pick-up location. The buyer is responsible for the dismantling, loading and transport for the purchased items. Dome Auctions accepts no liability whatsoever, unless otherwise stated. Collections will be available according to the above-mentioned schedule. In case of later collections, the customer is liable for the costs incurred (rent or any additional expenses), unless alternative arrangements have been agreed with the seller. In principle no loading aids such as forklift trucks or cranes are available. In special cases, loading aids may be available on request and for an additions charge.



Payment Details	<p>The invoice will be available in the buyers "Profile" section on our website and will be send by email directly after closing the auction.</p> <p><u>Full payment must be made within 48 hours</u> from the date the Purchase Agreement is available. Account details for money transfer are mentioned on the invoice.</p>
Information on Vat	<p>The statutory VAT is 8,1%. All foreign buyers must deposit the amount of VAT in the form of a deposit. This is also shown on the invoice. This deposit will be returned to you upon receipt of the original customs documents duly stamped as proof of Swiss exportation. The original Swiss export documents and the bank details to which the refund is to be made must be received by Dome Auctions within two months.</p>
General Terms and Conditions Of Use of Dome Auctions	<p>In addition to these Specific Online Auction Terms and Conditions the General Terms and Conditions of Use are applicable. In the event of a contradiction between the General Terms and Conditions of Use and these Specific Online Auction Terms and Conditions then these Specific Online Auction Terms and Conditions shall prevail.</p>
Combinations	<p>All lots in a combination will be sold individually first. After the last lot is sold, the total of the bids is raised by 5 %. This is the starting bid for the combination. If the combination is sold it overrules the individual bids, if not the individual bids are confirmed.</p>
Prolongation	<p>If a bid is made in the last 2 minutes before the lot closes, then the closing time will be extended by 2 minutes. With each subsequent bid the closing time will be extended by 2 minutes until no further bids are made.</p>
