Collection information: The buyer must bring their invoice with QR code to the collection location. The buyer is solely responsible for dismantling, loading, and transporting the purchased items. Dome Auctions accepts no liability unless stated otherwise. Collection is only possible according to the stated schedule. In case of late collection, the buyer is liable for any incurred costs (rent, insurance, or other additional costs), unless other arrangements have been made with the seller. In principle, no loading equipment such as forklifts or cranes is available. In exceptional cases, loading equipment may be made available upon request and at an additional cost.
