Important information

E-scooters

The vehicles are supplied with a deed of allocation issued by the curator. This document may be used by the buyer to independently submit a request for transfer of ownership or vehicle registration with the RDW (Netherlands Vehicle Authority). The assessment of the application and the final transfer or registration will be carried out in accordance with the RDW's terms, conditions, and procedures. The buyer is solely responsible for applying for registration, complying with all RDW requirements, and obtaining any additional documents, inspections, tests, or approvals that may be required. All costs and efforts associated with this process are at the buyer's expense. While every effort has been made to describe the scooters as accurately as possible, no rights can be derived from the information provided.

Technical Condition

The vehicles are sold in their current condition. It may be necessary for the buyer to carry out, or arrange to have carried out, certain work in order to make the vehicle operational or roadworthy. Any work, parts, technical inspections, and additional costs are entirely at the buyer's expense. Any instructions or explanations provided are offered solely as a service; no rights can be derived from them.

Keys / Chargers / Parts

Vehicles and lots are delivered strictly as described and shown. If keys, chargers, documents, parts, or accessories are not explicitly mentioned in the lot description, no rights can be derived from their absence.

Public Road Use

The buyer is solely responsible for complying with all legal requirements for use on public roads, including registration, insurance, and technical approval.

'GO' Marking

At the request of the consignors, Dome Auctions has covered the 'GO' marking on the lots offered for sale with an opaque sticker. Buyers are required to either keep these covering stickers in place or remove the 'GO' marking.



Notary

This auction is conducted under the supervision of the notary firm Krans Notarissen, based in Haarlem.

No Right of Withdrawal

No right of withdrawal applies to this bankruptcy auction. The sale takes place via a public auction, which means that, pursuant to Article 6:230p sub c of the Dutch Civil Code, the statutory right of withdrawal is excluded. Once the lot has been awarded, the purchase is final and binding. Cancellation or returns are not possible. The goods are sold in their current condition. By participating in the auction, the buyer expressly agrees to these terms.

Information about the Collection Date

The buyer must bring their payment receipt or invoice to the collection location. The buyer is responsible for dismantling, loading, and transporting the purchased items. Dome Auctions accepts no liability unless otherwise stated. Collection is possible according to the above schedule. In case of later collection, the customer is liable for the costs incurred (rental or other additional costs), unless other arrangements have been made with the seller. In principle, no loading aids such as forklifts or cranes are available. In special cases, loading aids can be provided upon request and at an additional cost. When visiting the collection site, all applicable safety regulations must be strictly observed. Wearing the required personal protective equipment, such as safety shoes, is mandatory. Instructions given by on-site personnel must be followed at all times.

General Terms

In addition to these Specific Auction Conditions, the General Terms and Conditions apply. In case of contradictions between the General Terms and Conditions and these Specific Auction Terms and Conditions, the Specific Auction Conditions prevail. By placing a bid, the buyer declares that, in addition to the terms and conditions of Dome Auctions, he expressly and unconditionally agrees to the terms and conditions of the party entrusted with the dismantling.

Payment Details

The invoice will be available in the "Profile" section of the buyer on our website and will be sent by email immediately after the auction closes. Full payment must be made within 48 hours from the time the Purchase Agreement is available. The payment details for the transfer are listed on the invoice.

Information about VAT

The statutory VAT is 21%. All foreign buyers from outside the EU must deposit the VAT amount as a security deposit.

Subject to allocation

Certain lots/combinations of lots may be offered subject to allocation. This is stated in the bidding information for the relevant lot. When lots are offered subject to allocation, the seller reserves the right to accept or reject the highest bid. Within five (5) business days, or earlier if possible, after the close of the auction (excluding Saturdays, Sundays, and Dutch public holidays), the bidder will receive an email on behalf of the seller regarding the award.

Combinations

All lots in a combination are first sold individually. After the last lot is sold, the total of the bids is increased by 5%. This forms the opening bid for the combination. If the combination is sold, it replaces the individual bids. If the combination is not sold, the individual bids remain valid.

Extension

If a bid is placed in the last 2 minutes before the lot closes, the closing time is extended by 2 minutes. With each subsequent bid, the closing time is extended again by 2 minutes until no new bids are made.

**Lot without Bid**

For all lots that have not been bid on, the closing time will be adjusted to half an hour after the last closing time of lots within this auction.
